

POOL RULES AND REGULATIONS

The following rules and regulations have been established by the Association for the protection and benefit of all members, and to assure sensible, safe and sanitary operation of the pool and facilities. The lifeguards will be directed by the Board and Management to strictly enforce these policies. Parents are requested to instruct their children and guests to observe all items listed below. Any failure to comply with these rules and regulations will result in a warning. Subsequent violations will result in a \$25.00 fine and may result in the suspension of pool privileges.

- 1. The pool at Yorkshire in accordance with the *Bylaws of the Master Association*, is only for use of:
 - a) The residents and guests of the single family homes of Yorkshire Village
 - b) The residents and guests of the townhouses of Yorkshire Meadows
 - c) The residents of the senior homes of Yorkshire Plaza
- 2. Residents/guests are required to show their valid pool badges to the lifeguard upon entry to the pool area and sign into the pool register indicating their house address/unit number and number of people. Each person is required to show their badge to the lifeguard in order to gain entry to the pool area. NO ONE will be allowed to enter the pool area without showing their pool badge. The only exception to this rule is a child under the age of three.
- 3. Guests may be introduced to the privileges of the pool, during pool hours, when accompanied by an adult resident (18 years of age and older) of *Yorkshire Village* or *Yorkshire Meadows*. Guest fees are \$5.00 for individuals 13 years of age and older and \$3.00 for children 3–12 years of age. There is no charge for children under the age of 3. *A maximum of 2 guest passes per address can be used per visit, subject to the volume of bathers in the pool.* Visitor passes can be obtained by contacting Property Manager Tricie Kohut at TMK Property Management for the YVMA homeowners or the leasing office for the Yorkshire Meadows residents. - 4. Any resident/guest showing evidence of any communicable skin diseases, sore or inflamed eyes, nasal or ear discharge, open blisters, cuts, bandages, excessive sunburn, colds, or any other contagious disease shall be refused admission to the pool/wading area.
- 5. At no time may anyone enter the pool area when the pool is closed, or a lifeguard is not present.
- 6. Residents/guests are not allowed to distract the lifeguard(s) by sitting next to them and engaging them in conversation or otherwise interfering with the performance of the lifeguard(s) primary duty to ensure the safety of the people in the pool.
- 7. Children under 16 years of age must be accompanied by an adult.
- 8. Residents/guests utilizing the pool facilities must do so in appropriate bathing attire.
- 9. All residents/guests must shower before entering the pool. This is a state regulation.
- 10. <u>DIAPERS</u> (and commercially approved diapered swimwear) ARE PROHIBITED IN THE LARGE POOL. All children using the larger pool must be toilet trained. <u>NO EXCEPTIONS</u>.

- 11. Small children in diapers are not only limited to using the wading pool but **must also wear** commercially approved diapered swimwear or plastic pants with snug fitting elastic waist and leg bands.
- 12. Horseplay, such as running, pushing, jumping, pulling others into the pool, towel snapping, use of profane language, or any other behavior creating a danger or annoyance is **strictly prohibited**. Failure to comply with the Authorized Pool Personnel and/or The Board of Trustees will result in subject(s) being removed from the pool/wading area.
- 13. Residents are responsible for the conduct of their guests, including any damage. The cost of any property damaged by a resident or guest of a resident will be charged to that resident's account.
- 14. **NO ANIMALS** are permitted at the pool/wading area at any time, except for service dogs.
- 15. **NO GLASS ITEMS** are permitted at the pool/wading area at any time.
- 16. **NO SMOKING** is permitted at the pool/wading area at any time.
- 17. **NO DIVING** is permitted at any time.
- **18. NO ALCOHOLIC BEVERAGES** are permitted at the pool/wading area during any normal operating day.
- 19. <u>SMALL POOL TOYS</u> (such as dive sticks/balls, water squirt toys, inflatable balls/rings and boogie boards) may be permitted **if they are used responsibly** and are not obtrusive to other swimmers. **Improper use and the removal of the toy(s) will be at the lifeguard(s) discretion.**
- 20. Foam "noodles" are permitted in the larger pool. Flotation devices such as tubes & rafts are permitted at the discretion of the lifeguard(s). While they may be allowed when the volume of bathers in the pool is low, when the pool is deemed too crowded, they may be restricted until a lower capacity is reached.
- 21. Infant toys <u>are permitted</u> in the wading pool, but parents should make sure that the toys do not obstruct the filtration system.
- 22. Parents are cautioned that the following practices are prohibited:
 - a. Placing baby carriages or playpens near the main pool or wading pool
 - b. Allowing toys to be scattered on the apron of the pool or walkways
 - c. Using crayons which melt in the sun
- 23. Obstruction of walkways is always prohibited.
- 24. The volume of portable radios must be kept at a low level so as not to disturb other residents/guests. Volume must be lowered at the request of another resident/guest.
- 25. The Authorized Pool Personnel and/or the Board of Trustees reserve the right to close the pool for maintenance operations, health conditions, safety issues, inclement weather, or any other reasonable cause deemed necessary at any time.
- 26. Any resident who has a delinquent account balance will not be admitted to the pool. The lifeguards will be notified of all residents with delinquent balances.
